	To be flexible in teaching group and 1:1 lessons for Sidcot School & Sidcot Swim School and any additional lessons as requested by the Sports Centre Manager.
	To communicate effectively with the Sports Centre Manager and with the Swim School Coordinator.
	<ul> <li>To be eager and willing to assist and lead Intensive Swimming Lessons and Swim School assessments during the school holidays.</li> </ul>
	To be willing to cover other swimming teachers' lessons in case of staff absence or illness, and to have a flexible approach towards working evenings and weekends.
	To check messages and shifts on Microsoft Teams and WhatsApp for any updates or changes to working hours.
	To report any equipment or building defects to the Supervisor on duty & to follow this up to ensure the Manager is informed.
	To be able to use booking systems on both computer and tablet & to complete registers and progress reports.

	To ensure all equipment is cleaned, dried & put away correctly and the poolside is tidy.
