<b>Job Title:</b>	School Nurse
<b>Summary of the role:</b>	<p>School nursing is a specialised practice of professional nursing that supports the well-being, academic success, and life-long achievement of students.</p> <p>The School Nurse must, facilitate positive student development; promoting and providing intervention services to support the safety, health and wellbeing of all students and staff.</p> <p>The School Nurse is a clinical practitioner, working as part of the small nursing team.</p>
<b>Main duties and responsibilities:</b>	<ul style="list-style-type: none"> <li>• Promoting and safeguarding the welfare of children and young persons for who you are responsible and with whom you come into contact.</li> <li>• Responsible for providing a clinically effective, high quality service to the students and staff of Sidcot School.</li> <li>• Managing day to day accidents, incidents or distress that affects the student’s physical and emotional wellbeing.</li> <li>• Respond quickly, calmly and effectively to emergency situations, managing the immediate needs of the casualty, the emergency services and others, within the school environment.</li> <li>• Communicate effectively with students, parents/guardians, Boarding House Parents, school staff, GP and other healthcare professionals (maintaining confidentiality).</li> <li>• Responsible for maintaining daily health records and medication records within the health centre, including electronic record keeping, and overseeing medical and medication records in the boarding houses.</li> <li>• Responsible for planning and implementing individual healthcare plans for students with medical conditions, disabilities in line with school policy, acting as named nurse to oversight care of students with healthcare plans.</li> <li>• Responsible for carrying out health surveillance, health promotion, and other public health initiatives.</li> </ul>
