<b>Job Title:</b>	School Cleaner
<b>Summary of the role:</b>	<p>General cleaning duties throughout all school areas in order to maintain key areas of functionality whilst adhering to current government legislation and school policy.</p> <p>Occasional weekends may be required but this will be limited to the schools commercial activity.</p>

<b>Main duties and responsibilities:</b>	<ul style="list-style-type: none"> <li>• Promoting and safeguarding the welfare of children and young persons for who you are responsible and with whom you come into contact.</li> <li>• To act in support of a domestic services department, performing a wide variety of general housekeeping, kitchen and laundry tasks both alone and in collaboration with other members of the department.</li> <li>• The ability to move furniture in order to clean correctly on routine and deep clean programs. (An example of furniture includes, but is not exhaustive to, all types of chairs, tables, beds etc with manual handling training where applicable).</li> <li>• Cleaning tasks include ablutions and washrooms, classrooms, offices, corridors, student rooms, common spaces and some kitchen areas. Bed making is required during the course of the schools commercial activities.</li> <li>• Be flexible to the changing demands of the job and have the initiative to keep yourself proactive with additional cleaning activities.</li> <li>• Complete other tasks commensurate to your trade and skill level as directed by the Domestic Services Coordinator or their deputy.</li> <li>• The ability to work alone and as part of a team with proven communication skills.</li> <li>• The ability to perform cleaning tasks with the use of mechanical floor cleaners and polishers with training.</li> </ul>
